

At Close, the Sensex was down 69.68 points or 0.11% at 60,836.41, and the Nifty was down 30.10 points or 0.17% at 18,052.70. About 1725 shares have advanced, 1630 shares declined, and 120 shares are unchanged.

At the close in NYSE, the Dow Jones Industrial Average fell 1.55%, to close at 32,148, while the S&P 500 index lost 2.50%, to end the week at 3,760, and the NASDAQ Composite index lost 3.36% to close at 10,525.

On the Multi-Commodity Exchange (MCX), Gold futures on were trading lower by 0.5% at Rs 50,351 per 10 grams and silver was down 1.07% at Rs 58,161 per kg.

U.S. West Texas Intermediate (WTI) crude futures retreated 59 cents, or 0.7%, to \$89.41. Brent crude shed 44 cents, or 0.5%, to \$95.72 a barrel.

The rupee depreciated 8 paise to 82.88 against the US dollar. At the interbank foreign exchange, the domestic unit opened at 82.87 against the dollar.
